## **CRNI's Policy Paper - Growing the sector**



#### Improving design, eliminating waste:

• Working with industry to improve design for repair & recycling

#### Changing behaviour:

- Quality mark to tackle public perceptions pilot project
- Build capacity for & work with companies on procurement



#### Supporting the Reuse & Recycling Sector:

- Set reuse on a level playing field
- Targets for reuse
- Improve KPIs & reporting on reuse

#### **Supporting Community:**

- Jobs /training scheme tailored for the reuse and recycling sector
- Better coordination & recognition of social enterprise

# So how do Reuse & Recycling relate to the Circular Economy?

- Reuse and recycling have a vital role to play in ensuring better and longer use of raw materials
- Under the Circular Economy Package at EU level, there is already recognition of reuse and recycling with targets for both
- Companies are under increasing pressure to safeguard their supply chains and designing their products for easier reuse and recycling is a way of doing this
- CRNI sees the development of the Circular Economy as an opportunity for the barriers to reuse and recycling to be overcome

## Reuse & Recycling - can we market "secondhand better?

CRNI would like to see more demand for reused and recycled goods. Is the lack of a Quality Mark or standard a barrier for consumers?

- An Green Enterprise-funded project kicks off in April to examine this area
- It's going to examine if a quality mark across a range of reused goods would improve consumers' perceptions of same
- Could such a mark, if developed, be used as a branding and marketing tool, showcasing the importance of such products in the development of the Circular Economy?

# What can we do in terms of moving towards the Circular Economy today?

- Get more wear out of your clothes! And then donate them to your local registered charity shop
- Ensure your old mattress gets recycled
- Check out the activities and events running during Reuse Month
- Keep using your IT equipment, such as your PC, mobile phone and laptop, until they actually need replacing
- Donate your old electronic equipment to a licensed recycler
- Does your business generate "waste" that another business could use?
- Does your business need to buy brand new or are reused/recycled goods an option?
- Invest in a reusable coffee cup and water bottle!
