Minutes of the 424th NESC Council Meeting, 18th December 2015

- 1. Minutes of the Meeting of November 2015 were approved.
- **2. Infrastructure**: Damian Thomas presented the paper circulated to Council, *Developing a New Approach to Infrastructure Policy*.
 - Council members strongly endorsed the paper, noting the strength of the case made for a new approach to infrastructure. Members highlighted the need to: further define what is meant by infrastructure; develop the functions and role of any possible new institutional arrangement and how these would complement existing approaches; ensure that infrastructure is viewed as an end not a means in itself; ensure that the new arrangements are not too narrowly associated with an overly technocratic and siloed approach; link this work with ongoing work around planning and the forthcoming National Planning Framework; highlight social and environmental criteria, particularly, in relation to evaluation. Note was also made of the importance of an all-island approach; the UN principles for responsible investment; the difficulties associated with measuring infrastructure deficits; the importance of asset management; the challenge of defining priorities, with the importance of housing emphasised—both wider housing infrastructure and social housing—and under-investment in skills and education. In addition, members highlighted: the cost of land in Ireland; the need to investigate long-run impact of PPPs; opportunities associated with changes to pensions and the prospect of auto-enrolment; the need to further develop the discussion on fiscal rules; the impact of demographic drivers, in particular in relation to education and ageing; the complexities associated with regional and rural development; the importance of how any new arrangements are communicated; the need to spell out the implications for existing institutions; the need to ensure that any new entity is not overly associated with any one political party; and, the link with government procurement and the Office of Public In closing, the Chair stated that the Secretariat would develop the paper, engaging in dialogue with relevant departments. A revised report would be brought back to the Council early in 2016.
